I, Paul N. Scherbel of Big Piney, Wyoming hereby certify that this map was made from notes taken during an actual survey made by me on 14 and 15 July 1971 and that it correctly represents the JACKSON HOLE SKI CORPORATION ADDITION—SEVENTH FILING of part of the N1/2SW1/4, Lot 7 and Lot 6 of Section 24, T42N, R117W, Teton County, Wyoming described as follows:
