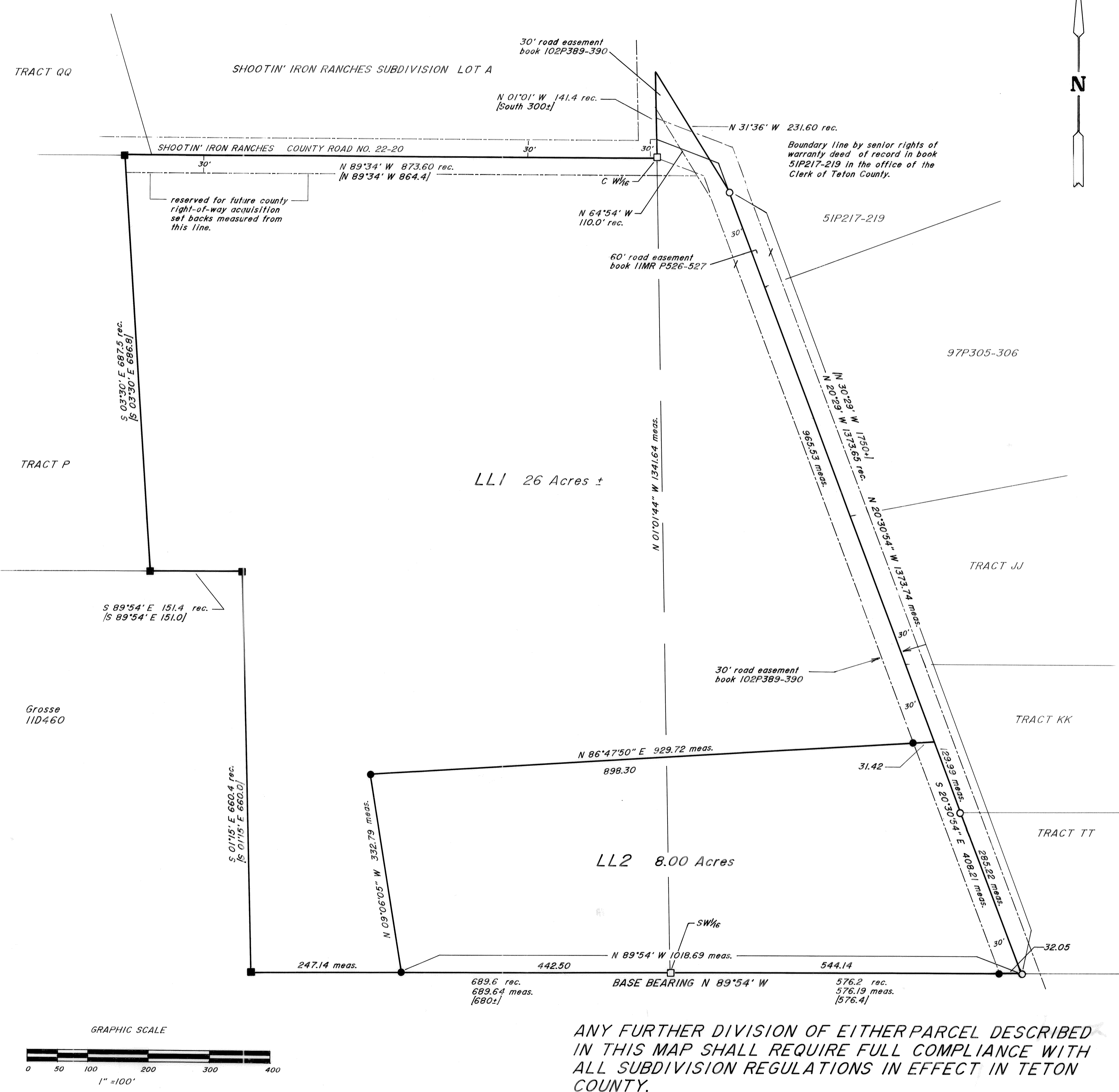
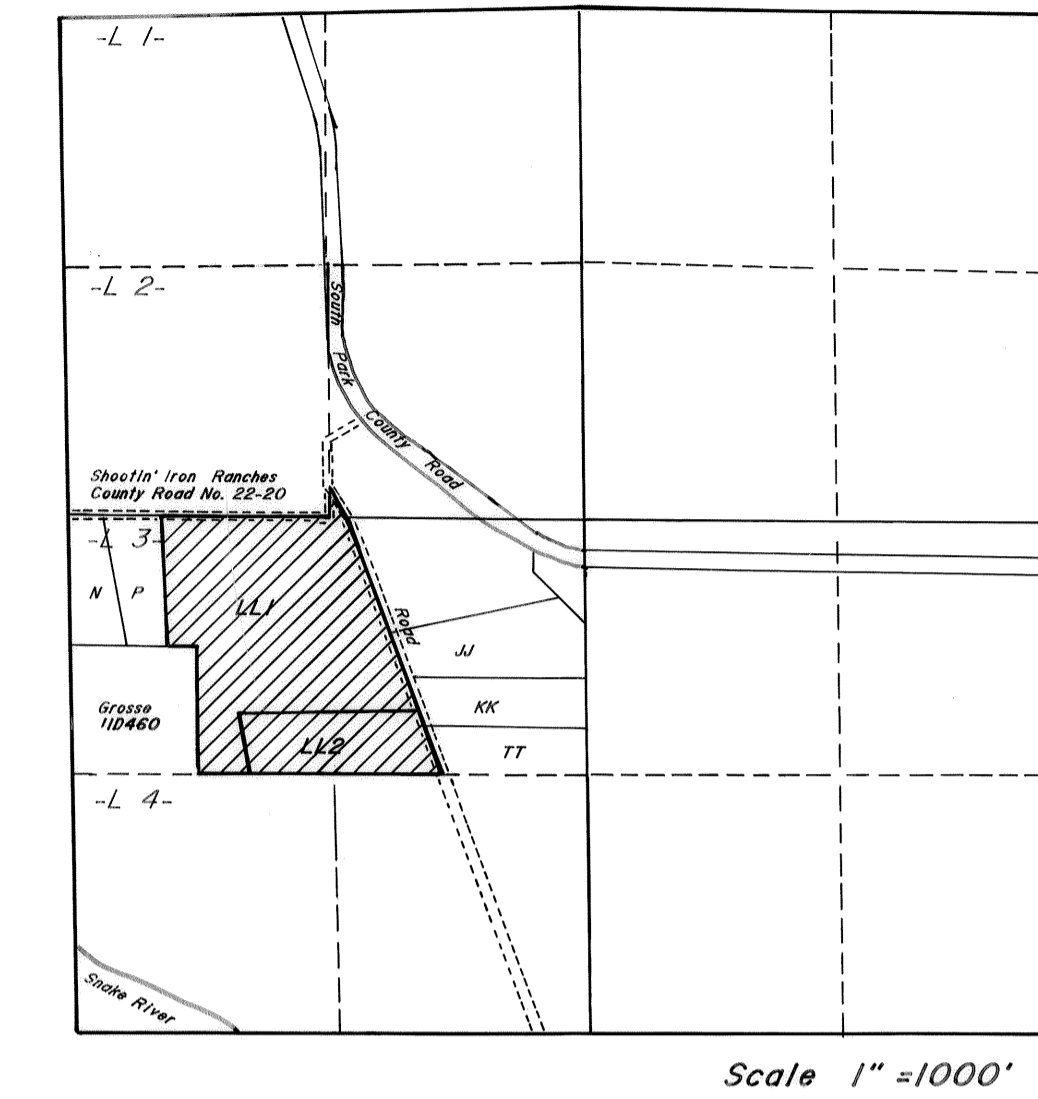


LOCATION MAP

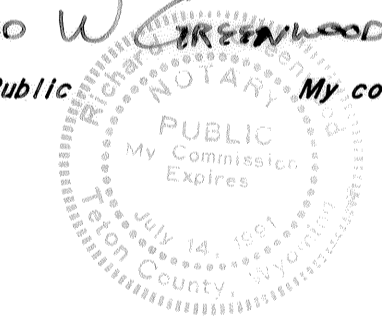
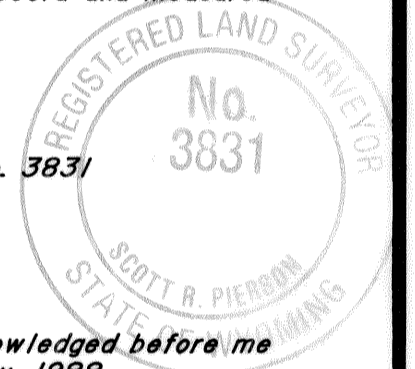
